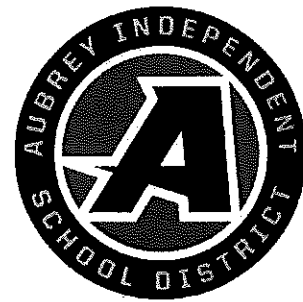


Notice of Special Meeting

Unless removed from the consent agenda, items identified within the consent agenda will be acted on at one time.

Pursuant to Governor Abbott's Temporary Suspension of Open Meetings Laws issued on March 16, 2020, this meeting will be conducted via videoconference, which will be audible to the Board and public and allow for two-way communication for the Board and district administration. All comments submitted will be read aloud to the Trustees during the Public Forum or Communications portion of the meeting.
